Project Title: Families at the Center in Southwestern Vermont

Project Summary: BROC Community Action, in partnership with the Rutland County Parent Child Center and the Sunrise Family Resource Center in Bennington, will develop and pilot a family centered navigation approach to improve service coordination and family economic stability using a two-generation approach. This project will be undertaken in collaboration with the State of Vermont's Reach-Up (TANF) Program and the Administration for Children and Families Region 1 (U.S. Department of Health & Human Services). The planning and demonstration process will simultaneously engage both parents and children to design a two-generation service model. A primary goal of the project is to create a mechanism that facilitates policy change at multiple levels and addresses the barriers identified at a local level in Rutland and Bennington counties to benefit all Vermont families.

Project Title: 2Gen Approach to Maternal and Child Health

Project Summary: Community of Hope (COH) will enhance its maternal and child health services by integrating two services and strengths: 1) the provision of emotional wellness services and 2) parenting supports for perinatal patients and families with young children at risk of toxic stressors. Using a 2Gen approach that considers how depression, anxiety and other emotional wellness issues can impair a caregivers' ability to parent, COH will enhance the emotional wellness supports for families participating in COH's home visiting programs with the addition of two new staff positions: Lead Behavioral Health Specialist and a Lead Home Visiting Family Case

Manager. Program goals are to help underserved families achieve healthy pregnancies, maintain wellbeing during the postpartum period, and raise children in healthy, supportive, and enriching environments.

Project Title: Uniting Families with Education

Project Summary: Founded in 1963, Tri-C is Ohio's oldest and largest public community college. Building on the success of Tri-C's Adult Diploma program, Tri-C's 2GEN approach will help adults lacking a high school diploma and their young adult/teenaged children at risk of dropping out to persist, together, in earning a high school diploma and a workforce credential, thereby creating a pathway out of poverty. Tri-C will provide intensive and coordinated education and individualized supports to 50 families (100+ parents, teens and other family members) with significant barriers to employment, such as literacy, work readiness and mental and physical health challenges. Activities will include recruitment, assessment, classes, counseling, case management, and evaluation.

Project: Enterprise Communities Plus 2Gen Initiative

Project Summary:

EC Plus 2Gen addresses the need to proactively reach families living in affordable housing who are at risk of housing instability, and to connect them to services early to avoid crisis. With a 2Gen housing-based services approach, EC Plus aims to maximize the housing stability, economic mobility, and well-being of families with low incomes through place-based outreach, partnerships with families, collaboration between service providers and property managers, multigenerational service coordination, and family coaching. The approach is centered around identifying factors that undermine a family's overall well-being, and working with the family to solve problems, access new resources, and sharpen existing skills. During the planning period, Enterprise Community Partners established and piloted the partnership between Harlem Congregations for Community Improvement, Inc. HCCI, an affordable housing provider, Goddard Riverside Community Center, a neighborhood-based services hub, and families living in Central Harlem.

The overall purpose is to build the capacity of immigrant parents to use literacy and language skills to improve their children's healthy development and school readiness.

Project Title: 2Gen Family Bridge to Workforce Services

Project Summary: To improve parents' earnings, family stability and well-being, Towards Employment (TE) will implement a Whole Family Approach to Workforce Services (WFWS) that bundles intensive career services and financial coaching with family supports. WFWS will be offered to caregivers in TE Career Pathways programming who have children ages 12 and under, as well as TE alumni. Services will be delivered through a cohort model, supported by a new 2Gen coordinator position, and leveraged through a collaboration of community partners for enhanced family supports.

Project Title: 2Gen Pediatric Primary Care

Project Summary: The United Hospital Fund will strengthen the Partnerships for Early Childhood Development (PECD) 2Gen approach. PECD is helping to develop formalized systems of care between health care providers and social services organizations to address social determinants of health. Eight participating PECD pediatric primary care practices screen young families during the child's well visits for social and environmental risks that interfere with healthy development and connect families, through partnerships with community-based organizations, with services that can address those risks. The clinical partners are BronxCare Health System; Cohen Children's Medical Center (part of Northwell Health); The Mount Sinai Hospital; New York-Presbyterian/Columbia University Irving Medical Center; New York-Presbyterian Queens; NYC Health + Hospitals/Gotham, Gouverneur Health; NYU School of Medicine/Family Health Centers at NYU Langone; and St. John's Episcopal Hospital.
