For Family Directed Giving, nearly \$400,000 was allocated with a family participation rate of 91.5%!

We're moving the Family Directed Giving deadline to October 31st – Halloween, a date that's easy for us all (even the kids!) to remember.

What's New in 2022

In Fluxx, the hope is that you will be able to:

- View your Family Directed giving history;
- Look up a new organization that you're interested in giving to, to make sure that the organization is a qualified 501(c)3; and
- Fill out a short request form to designate a Family Directed gift.

Once Fluxx is ready to go "live", the Foundation's staff will offer trainings and resources for how to use the new system. Please stay tuned!

Letter from the CEO



A year ago, we began a new strategic planning process. As noted then, it had been a decade since the vision, mission, and values that guide our work were agreed upon.

An extensive data collection process yielded some proposed changes to the vision, values and mission (still in draft, on page 10). What remains the same: the importance of making an **impact** with our grant dollars and **engaging O'Neill family members** in the foundation's work.

The strategic planning committee – Bob Donahey, Brian Sweeney, Mary France Walker, Molly McShane, Maureen O'Neill, and Sara O'Neill Sullivan – has been meeting both with the facilitators from 21/64 and as a small group to craft new ideas around impactful grantmaking and family engagement.

While we had hoped to be back in communities making in-person site visits this cycle, we determined that it is better to wait for Cycle 2 as many grantee partners are still navigating their way back to in-person work! We still hope to reconnect in-person in 2022.

One Family's Story

At the height of the pandemic in New York, Dalliana and Brandon Mellette took off to a birthing center in Brooklyn. In less than 24 hours, baby Lobo was born and was back home.

Lobo came into the world at a time of unprecedented crisis. With a raging pandemic happening in New York, hospitals were eager to minimize the time patients spent in healthcare settings.

Dr. Robin Scott from the Bronx Health Collective – a program supported by ONF's grantee partner, the Children's Health Fund – had been Brandon's pediatrician since inception and also cared for many members of his family.

"Dr. Scott was someone that I knew I wanted to take care of Lobo. She has been taking care of all the Mellettes. Me, my sisters, my aunts, my cousins, everyone."

The pandemic caused Dalliana and Lobo to be released from the birthing center when he was only a few hours old. Two days later, at Lobo's first pediatric appointment, Dr. Scott noticed that he looked a little yellow, as if he were jaundiced.

When the labs came back, they confirmed that he had elevated levels of bilirubin, a common newborn problem. (If his bilirubin levels got high enough, they could cause permanent brain damage). Baby Lobo needed to go to the hospital immediately for treatment.



Navigating healthcare settings during the pandemic was not easy, but Dr. Scott made the calls and arrangements to ensure all was ready when Dalliana and Lobo arrived at the hospital. What could have been a very serious situation during the pandemic, was not.

2Gen/DIG Update

[January 2022] The 2Gen Learning Community convened to discuss parent engagement and leadership practices. The group was joined by Sarah Haight, Director of 2Gen Practice, who provided updates from Ascend at the Aspen Institute.

According to the latest 2Gen grantee partner survey, below are a few examples of how ONF's grantee partners are using family voice to shape their 2Gen programs:





Created Facebook groups, advisory boards, and focus groups for families to engage with each other, ask questions, and share experiences.



Hired a student-parent Program Coordinator to shape service delivery and accessibility.



Enrolled 2Gen ambassadors to recruit other families.



Involved young adults in canvassing efforts and solicited their creativity.



Supporting Families with Pre-School-Aged Children

ONF's 2Gen/DIG grantee partner, Family Partners, is an initiative of the Sisters of Charity Foundation & Cleveland Central Promise Neighborhood.

When Family Partners wrapped up its inaugural year in 2020, program adaptations to support families through COVID-19 were still necessary. Families engaged through virtual "home visits", telehealth sessions, and remote activities. Family Partners' staff navigated these shifts and have since added more activities to address the changing economic landscape, and meet families' increased needs for employment, food, and educational services.

ONF funded the first three years of the Family Partners program. Now in Y3, they are focused on program and partner development and exploring ways to deepen the web of support for families.

Where are They Now?

[December 2019] The Trustees approved a \$100,000 grant for the Working Communities Challenge (WCC) in Vermont.



WCC's initiative supports diverse, local teams as they tackle complex challenges facing their communities. With a focus on creating economic opportunities for communities and residents with low incomes, this three-year grant competition is supported by the Federal Reserve Bank of Boston, the State of Vermont, national and local philanthropy, and private sector employers.

[Spring 2022] Vermont provided \$2.32M to expand WCC, doubling the number of community teams (WCC's grant awardees) that are tackling tough, local economic issues such as aging populations, low labor force participation, and entrepreneurship. One of WCC's newest teams is in Southern Vermont and plans to establish initiatives that grow and retain a diverse workforce in Bennington and Windham counties.

ONF staff recently connected ONF's Vermont DIG partner with WCC. We were pleased to learn they shared their learnings from the DIG planning process about ways to improve state and local services to help parents and families.

In June 2022, all WCC's regional teams will meet for their first, in-person statewide gathering.

NextGen Learning in the Field

[March 2022] Alissa Casazza and Mary France Walker joined other NextGen for a conversation about building leadership within family spaces. The National Center for Family Philanthropy's Emerging Family Leaders Peer Network provides an opportunity for next generation family members (ages: 21 – 45) to advance their grantmaking and leadership development, both personally and professionally.

This was my first time participating in a [National Center for Family Philanthropy] NCFP program. Despite the differences in size, structure, and specific interests of each unique family foundation, there were many commonalities in both challenges and steps taken to overcome them to run a successful, as well as impactful, philanthropic organization. A few of the obstacles that we discussed were adjusting operations through Covid, participation and the involvement of younger generations, and strengthening relationships between multiple generations.



I was very pleased and proud that the O'Neill Foundation has been proactive and (in my opinion) well ahead of the curve in navigating through, as well as overcoming, many of these challenges. I believe that the sharing of knowledge, experiences, collaboration, and encouraged participation throughout multiple generations within a family foundation are the keys to success.
